NOTICE OF PUBLIC HEARING AT TOWN HALL OR BY TELECONFERENCING (Novel Holden Solar Garden)

NOTICE IS HEREBY GIVEN, that per Resolution R2021-05 passed by the Town Board on June 14, 2021, Township meetings (Regular, Special, Work Sessions, Planning Commission, Public Hearing & Committee) will be held both at the Town Hall (3847 321st St. W, Northfield, MN) and by teleconferencing by GoToMeeting until the coronavirus pandemic is declared over.

Public Hearing will be held at the Town Hall on Monday, February 14, 2022 at 6:00 p.m. The purpose of the Public Hearing is to consider an Interim Use Permit for the installation and construction of a retail solar electric system located on a 80.70 acre site that will encumber approximately 12 acres with solar panels and appurtenances. The proposed project is for a fixed, photovoltaic ground mounted 1 MW capacity solar field. The proposed project would have a contract life of 25 or more years. The site is located at 2639 330th St. W. in Waterford Township. PID – 41-02800-50-010 in Section 28, Township 112 Range 19. The IUP application by Eastgate Farms, Inc. with Novel Energy Solutions, LLC requires a public hearing and the opportunity for residents to provide comment on the proposed project.
